We are a wholly owned subsidiary of Focus Financial Partners, LLC (“Focus”), and Focus is a minority investor in UPTIQ, Inc. The range of services offered or expected to be offered by UPTIQ to our advisory clients includes, but is not limited to, omnibus cash management products, individual level deposits, non-purpose securities-backed lines of credit, commercial loans, aircraft and marine loans, non-securities-based/asset-secured loans, and residential mortgage loans. When legally permissible, UPTIQ and Flourish each shares a portion of this earned revenue with an affiliate of our firm. The affiliate distributes this revenue to us when we are licensed to receive such revenue (or when no such license is required) and the distribution is not otherwise legally prohibited. Our affiliate, Focus Risk Solutions, LLC (“FRS”), assists our clients with regulated insurance sales activity by advising our clients on insurance matters and placing insurance products for them and/or referring our clients to licensed insurance brokers, which either separately or together with FRS, place insurance products for them. Certain of these brokers pay FRS periodic fees to participate in the FRS platform and, thereby, to offer their services to our clients and certain of our affiliates’ clients. If FRS places an insurance product or refers one of our clients to an insurance broker and there is a purchase of insurance through the broker, then FRS will receive a portion of the upfront and/or ongoing commissions associated with the sale by the insurance carrier with which the policy was placed. The amount of insurance commission revenue earned by FRS is considered for purposes of determining the amount of additional compensation that certain of our financial professionals are entitled to receive. The receipt of performance-based fees gives Prairie an incentive to recommend that clients allocate assets to the Flint Hills funds over other investments that do not pay performance-based fees. This conflict is mitigated through full and fair disclosure of the compensation and the fact that our clients invest in the funds on a nondiscretionary basis.
