AS A GENERAL MATTER, MILLINGTON ROUTES ORDER FLOW TO CERTAIN MARKET MAKERS FOR EXECUTION. DURING THE RELEVANT PERIOD, MILLINGTON RECEIVED PER SHARE PAYMENTS (E.G., PAYMENT FOR ORDER FLOW) FROM DESTINATION MAKER MAKERS.
