IN MAY 2019, DEERPATH BECAME AWARE THAT STATE OF THE CALIFORNIA HAS A CALIFORNIA FINANCING LAW ("CFL") THAT REQUIRES FINANCE LENDERS MAKING AND BROKERING CONSUMER AND COMMERCIAL LOANS IN CALIFORNIA TO BE LICENSED AND REGULATED. AFTER BECOMING AWARE OF THE CFL REQUIREMENTS, DEERPATH PROMPTLY CONTACTED LEGAL COUNSEL AND SUBMITTED A LICENSE APPLICATION IN AUGUST 2019 FOR DEERPATH FUNDS' FUTURE LENDING ACTIVITIES IN CALIFORNIA AND VOLUNTARILY SELF-REPORTED LOANS DEERPATH MADE IN CALIFORNIA PRIOR TO BECOMING AWARE OF THE CFL REQUIREMENTS. BY WAY OF BACKGROUND, DEERPATH BEGAN ITS BUSINESS AS AN INVESTMENT MANAGER OF SMALL BUSINESS INVESTMENT COMPANIES ("SBICS") IN 2009 AND ONLY MANAGED SBICS UNTIL 2013. BECAUSE SBICS ARE EXPRESSLY EXEMPT FROM CFL LICENSING REQUIREMENTS, DEERPATH DID NOT PURSUE LICENSURE FOR ITS ACTIVITIES WHEN ESTABLISHING ITS BUSINESS.
