SO, I ASKED MY FIRM TO REGISTER ME, AND MY FIRM'S COMPLIANCE OFFICER AT ONE POINT TOLD ME THAT MY APPLICATION TO NEW MEXICO HAD BEEN ACCEPTED. I THEN COMMUNICATED WITH THE CUSTOMER THINKING I WAS REGISTERED IN NEW MEXICO, BUT IT TURNED OUT THAT MY REGISTRATION DID NOT BECOME EFFECTIVE UNTIL LATER. I WAS FULLY REGISTERED IN NEW MEXICO BEFORE I EXECUTED MY FIRST TRADE WITH THE CUSTOMER, SO THE DISCLOSURE ABOVE, THAT I USED ANOTHER BROKER'S REGISTRATION NUMBER IN EXECUTING A TRADE, IS INCORRECT. NEVERTHELESS, THE NASD FOUND THAT MY COMMUNICATION WITH THE CUSTOMER BEFORE MY OWN REGISTRATION WAS EFFECTIVE WAS A VIOLATION AND THAT MY INSISTENCE THAT I WAS REGISTERED AMOUNTED TO LYING TO THE NASD ABOUT IT.
