The special purpose vehicles (“SPVs”) that serve as general partners and/or sponsors to the pooled investment vehicles listed in Section 7.B.1 are themselves identified in Section 7.A. as “other investment advisers” in a manner consistent with the treatment of similarly situated SPVs of registered investment advisers as articulated in the no-action letter to the Business Law Section of the American Bar Association (Jan. 18, 2012). However, the RAUM reported in Item 2.B does not “double-count” the capital raised by the Feeder Funds.
