IN FEBRUARY 2018, THE SECURITIES AND EXCHANGE COMMISSION ("SEC") ANNOUNCED THE CREATION OF A "SHARE CLASS SELECTION DISCLOSURE INITIATIVE" (THE "SCSD INITIATIVE"). THE SCSD INITIATIVE APPLIED TO INVESTMENT ADVISERS THAT SELECTED MUTUAL FUND SHARE CLASSES FOR CLIENTS, WHICH PAID THE ADVISER OR RELATED ENTITIES OR INDIVIDUALS A FEE PURSUANT TO RULE 12B-1 OF THE INVESTMENT COMPANY ACT OF 1940 ("12B-1" FEE) WHEN A LOWER-COST SHARE CLASS FOR THE SAME FUND WAS AVAILABLE TO CLIENTS.DURING THE PERIOD IN QUESTION, MIAI INCLUDED DISCLOSURE ON ITS RECEIPT OF 12B-1 FEES IN ITS FORM ADV AND INVESTMENT ADVISORY AGREEMENTS.AS PART OF THE SCSD INITIATIVE, THE SEC ASKED INVESTMENT ADVISORY FIRMS TO VOLUNTARILY REVIEW THEIR DISCLOSURES DATING BACK TO 2014 AND REFUND TO INVESTORS 12B-1 FEES WHEN, IN THE SEC'S VIEW, THE FIRM DID NOT FULLY DISCLOSE CONFLICTS OF INTEREST ABOUT THESE FEES.
