Item 5.J.(2) Donoghue Forlines LLC reports client assets in Item 4 of Form ADV Part 2A that are computed differently than the method used to compute regulatory assets under management. We report client assets that include both regulatory assets under management and assets under advisement. Assets under advisement are assets managed by third-party financial advisors who manage their client accounts using our model portfolios and related trading signals. As of December 31, 2025, the firm maintained these model portfolio relationships with approximately 18 firms and platforms through which advisers applied our models in managing their client accounts valued at \$234 million. The firm receives compensation from these third-parties based on a percentage of their client assets to which the model portfolios and trading signals are applied. Approximately \$214 million of assets under administration is allocated to funds and ETFs advised by Donoghue Forlines and included in regulatory assets under management.
