Incision Capital Management LP ("Incision") is filing this Form ADV to withdraw from Exempt Reporting Adviser status and register with the SEC as an investment adviser. On January 27, 2026, Incision filed its annual updating amendment reporting regulatory assets under management, as of December 31, 2025, of \$124,340,516. That figure was calculated on a net asset value basis and was incorrect. The correct figure, calculated on the gross basis, was \$234,754,495. Incision's January 2026 annual updating amendment was the triggering event for a 90-day period in which to apply for registration with the SEC, ending April 27, 2026. Because the January amendment misreported regulatory assets under management, Incision did not recognize at that time that the 203(m) exemption was no longer available and that the 90-day registration window was running. Incision identified the error internally on May 7, 2026 and contacted outside counsel the same day. Incision has worked continuously to complete this registration since the error was identified. Incision is not aware of any client or investor harm resulting from the delay. No client complaint or regulatory inquiry preceded Incision's discovery of the error. Incision has documented the error and corrective internal process-change steps in its books and records. The gross asset value reported in this Form ADV

(\$220,288,168) is calculated as of March 31, 2026, a date within 90 days of this filing.
