FUSE / Completed SPAC Transaction In January 2022, Consilium Acquisition Corp I, Ltd. ("Consilium Acquisition Corp"), a special purpose acquisition company,

completed its initial public offering on the Nasdaq Stock Market. The SPAC was sponsored by Consilium Acquisition Sponsor I, LLC (the ‘Sponsor’), which was owned by Consilium Investment Capital, Inc. (‘CIC’, the Registrant’s controlling member) and by the Consilium Extended Opportunities Fund, LP (a client fund of the Registrant). Jonathan Binder and Charles Cassel, the Registrant’s principals, held interests in the Sponsor indirectly through their ownership of CIC. Consilium Acquisition Corp was subsequently renamed CSLM Acquisition Corp. In October 2025, CSLM Acquisition Corp completed its business combination with Fusemachines, Inc. (NASDAQ: FUSE). In connection with the closing, the Sponsor was dissolved and its FUSE shares were distributed to the Consilium Extended Opportunities Fund, LP and, in respect of CIC’s interest in the Sponsor, to Messrs. Binder and Cassel personally. Separately, the Consilium Frontier Equity Fund, LP participated in a PIPE financing in connection with the business combination. As a result, FUSE shares are held by client funds of the Registrant and personally by the Registrant’s principals. The Registrant maintains pre-clearance controls and conflict-management procedures as described in Part 2A, Item 11. Sophus Capital LLC Sophus Capital LLC (“Sophus”) is a Delaware limited liability company with its principal office at 224 Greenwood Drive, West Palm Beach, Florida 33405. Sophus serves as the Class B Member of the Registrant’s operating company pursuant to an Amended and Restated Operating Agreement effective March 1, 2026. The sole member of Sophus is Michael L. Reynal, who also serves as Chief Investment Officer for the Registrant’s Global Emerging Markets strategy and as one of three Managers of the Registrant’s operating company. Sophus holds a Class B profits interest in the Registrant’s operating company. The profits interest entitles Sophus to participate in profits attributable to the Global Emerging Markets (“GEM”) and Emerging Markets Small Cap (“EMSC”) investment strategies. Sophus made no capital contribution and holds no capital interest. Sophus provides portfolio management personnel to the Registrant under a Personnel Services Agreement and non-discretionary research personnel under a Research Services Agreement. The Registrant’s Chief Compliance Officer has supervisory authority over all such personnel. The Registrant operates the GEM and EMSC strategies under the “Sophus Capital” brand pursuant to a royalty-free trademark license from Sophus. Sophus is not a registered investment adviser, broker-dealer, or investment company. The Registrant serves as investment sub-adviser to Empowered Funds, LLC (d/b/a ETF Architect), the primary ETF adviser, through the EA Series Trust (CIK: 0001592900; 811-22961). The Registrant sub-advises two ETFs under this arrangement: Sophus Capital Emerging Market ETF (NASDAQ: EMEM; Series S000101899), which commenced operations on May 20, 2026, and Sophus Capital Emerging Market Small Cap ETF (NASDAQ: EMSC; Series S000101900), which commenced operations on May 21, 2026. The Registrant’s portfolio management personnel make all investment decisions and generate trade instructions; the primary ETF adviser is responsible for trade execution, fund operations, and regulatory compliance at the fund level. The Registrant retains supervisory oversight of the investment decision-making process. Empowered Funds, LLC is not a related person of the Registrant. CSLM Digital / KOYN Charles T. Cassel, III, the Registrant’s CEO and CCO, served as a director (non-officer) of CSLM Acquisition Sponsor II, Ltd. (the “Sponsor”) until November 25,2025, and continues to serve as a director (non-officer) of CSLM Digital Acquisition Corp III, Ltd. (“CSLM Digital”), a special purpose acquisition company (NASDAQ: KOYN). Consilium Investment Capital, Inc. (“CIC”), the sole Class A Member of the Registrant’s operating company, holds approximately 4% of the Class A shares, 0.174% of the Class B shares, and 49% of the Class C shares of the Sponsor. The Registrant does not hold any position in KOYN or the Sponsor in client accounts as of the date of this filing. See Part 2A Items 10 and 11 for additional disclosure.
