All SLOAs accepted by the Adviser comply with the seven conditions established in the 2017 Guidance Update, including that: The qualified custodian obtains written authorization from the client that names the designated third-party recipient and the Adviser; The qualified custodian verifies the instruction, performs an independent signature verification, and provides transfer notices to the client; and The Adviser maintains records of each authorization and monitors transactions under the firm’s compliance and supervisory procedures. Because the Adviser’s custody is limited to these SLOA arrangements, the firm is not required to obtain a surprise custody examination under Rule 206(4)-2(b)(4). Clients continue to receive account statements directly from the qualified custodian at least quarterly, and are encouraged to review those statements carefully and compare them to any reports provided by the Adviser.
