INSTEAD OF BEING PLACED IN BRIDGE LOANS, HOWEVER, THE MONEYS WERE PART OF THE INDIVIDUAL'S \$60 MILLION PONZI SCHEME. IN JANUARY 2007, PRIOR TO PLACING HIS CLIENTS' INVESTMENTS WITH THE FEEDER FUND AND THE COMPANY, THE PRINCIPAL PROMISED TO CONDUCT DUE DILIGENCE TO AT LEAST TWO CLIENTS PRIOR TO PLACING HIS CLIENTS INTO THE FEEDER FUND INVESTMENT. ALTHOUGH THE PRINCIPAL ASKED FEEDER FUND REPRESENTATIVES SEVERAL KEY QUESTIONS, HE RECEIVED INCOMPLETE, CONTRADICTORY, AND EVASIVE RESPONSES. HE RECEIVED NO FINANCIALS. BECAUSE THE FEEDER FUND HAD NO OFFICES, THE PRINCIPAL MET THE THREE REPRESENTATIVES -- ONE OF WHOM THE PRINCIPAL BELIEVED WAS A UPS TRUCK DRIVER OR DELIVERYMAN - - AT LOCAL RESTAURANTS TO DISCUSS THE INVESTMENT. DESPITE THESE RED FLAGS, THE PRINCIPAL PLACED FOUR YOSEMITE CLIENTS INTO THE FEEDER FUND INVESTMENT WITHOUT DISCLOSING TO CLIENTS THAT HIS DUE DILIGENCE PROCESS HAD BEEN THWARTED.
