The Registrant's only pooled investment vehicle, Element Global Technologies Private Portfolio Ltd, is organized in the British Virgin Islands and is a non-U.S. client whose beneficial owners are non-U.S. persons. The Registrant controls that fund and is therefore deemed to have custody of the fund's assets as a factual matter. In addition, the Registrant's related person, Raison Securities Ltd (a broker-dealer regulated by the Astana Financial Services Authority), introduces and executes transactions for certain non-U.S. separately managed account clients; those client assets are held by independent licensed custodians (including but bot limited to Pershing (London) and the AIX Central Securities Depository) on an omnibus basis, with client assets segregated from the proprietary assets of Raison Securities and each client recorded in the off-the balance books and records of Raison Securities. Raison Securities does not itself safeguard client assets. Consistent with the long-standing position of the SEC staff, the

substantive provisions of the Investment Advisers Act, including Rule 206(4)-2, are not applied to the non-U.S. clients of an SEC-registered offshore adviser. Accordingly, the Registrant has responded to Item 9.A.(1) "No." The Registrant has responded to Item 9.B.(1) "Yes" to reflect, as a factual matter, that its related person participates in custodial arrangements for non-U.S. clients, while noting that the substantive custody provisions are not applied to those non-U.S. clients.
