On March 31, 2026, Cynosure Portfolio Advisors intended to submit its Annual Updating Amendment to Form ADV. Due to an administrative input error in IARD, a “State Initial” filing was inadvertently selected instead of an Annual Updating Amendment, which initiated filings with seven states. The firm did not intend to register or notice file in those states and intended to remain registered with the SEC. Upon identifying the error, the firm promptly submitted Form ADV-W filings to withdraw the unintended state filings. The firm was unable to complete the Annual Updating Amendment until the state withdrawals were processed, because the unintended state filings continued to appear in IARD. Separately, on May 15, 2026, while assisting with a Form U4-related matter, the firm’s consultant, ACA, submitted an Other-Than-Annual Amendment to Form ADV. The filing was administrative in nature, was submitted without prior notice to Cynosure, and was not intended by the firm to satisfy its Annual Updating Amendment obligation. An Other-Than-Annual Amendment does not satisfy the firm’s annual updating amendment requirement. Cynosure Portfolio Advisors is submitting this Annual Updating Amendment on May 27, 2026, to complete the annual update and satisfy its Form ADV annual updating amendment obligation.
