At the same time, Lansdowne Developed Markets Master Fund Limited was

divided between Lansdowne Developed Markets Opportunities Master Sub-Fund and the Z Shares Master Sub-Fund. Lansdowne Developed Markets Opportunities Sub-Fund invests all of its investment assets in Lansdowne Developed Markets Opportunities Master Sub-Fund and the Z Shares Sub-Fund invests all of its investment assets in the Z shares Master Sub-Fund, in a master-feeder structure. LDM Long Only Sub-Fund invests all of its investment assets in management and performance fee-free classes of ordinary shares in Lansdowne Developed Markets Long Only Fund Limited. Following a further reorganization effective February 2, 2026, an additional Sub-Fund of Lansdowne Developed Markets Fund Limited was created, the LDM Critical Minerals Sub-Fund. At the same time, an additional Sub-Fund of the Lansdowne Developed Markets Master Fund Limited was created, the LDM Critical Minerals Master Sub-Fund. The LDM Critical Minerals Sub-Fund invests all of its investment assets in the ordinary shares of the LDM Critical Minerals Master Sub-Fund. Following a reorganization effective October 1, 2020, Lansdowne Developed Markets Fund LP was divided into two Sub-Funds: Lansdowne Developed Markets Opportunities Sub-Fund and the Z Interests Sub-Fund. At the same time, Lansdowne Developed Markets Master Fund Limited was divided between Lansdowne Developed Markets Opportunities Master Sub-Fund and the Z Shares Master Sub-Fund. Within the Lansdowne Developed Markets Fund LP, Lansdowne Developed Markets Opportunities Sub-Fund invests all of its investment assets in Lansdowne Developed Markets Opportunities Master Sub-Fund and the Z Interests Sub-Fund invests all of its investment assets in the Z shares Master Sub-Fund, in a master-feeder structure.
