FINALLY, THE SEC ORDER STATES THAT THE FIRM FAILED TO IMPLEMENT ITS COMPLIANCE POLICIES FOR VALUING FUND SECURITIES BY PLACING BIDS ON BONDS THE FUND ALREADY OWNED AT PRICES HIGHER THAN THOSE QUOTED BY THE FUND'S INDEPENDENT PRICING SERVICES. THE ADVISER AGREED AS PART OF THE SETTLEMENT TO A CENSURE AND PAY A CIVIL MONETARY PENALTY OF \$3.5 MILLION TO THE SEC.
