THE ORDER WITH RESPECT TO MR. EMBRY WAS LIMITED TO THE FAILURE OF MEADOWBROOK TO ALERT MR. EMBRY OF HIS OBLIGATION TO REGISTER AS AN INVESTMENT ADVISER REPRESENTATIVE IN THE STATE OF MICHIGAN. THE ORDER WITH RESPECT TO MEADOWBROOK INVOLVED MR. EMBRY'S LACK OF REGISTRATION AS AN INVESTMENT ADVISER REPRESENTATIVE, AS WELL AS MEADOWBROOK'S FAILURE TO FILE THE REQUIRED NOTICE FILINGS TO THE STATE OF MICHIGAN WITH RESPECT TO THE FIRM'S REGISTRATION AS AN INVESTMENT ADVISER WITH THE COMMISSION. IN COMPLYING WITH MICHIGAN REQUIREMENTS ON INVESTMENT ADVISER REPRESENTATIVE REGISTRATIONS, MEADOWBROOK MADE A MISTAKE INVOLVING MR. EMBRY. MEADOWBROOK PAID BOTH OF THESE FINES. MEADOWBROOK ALSO FAILED TO RECOGNIZE THAT A NOTICE FILING TO THE STATE OF MICHIGAN WAS REQUIRED AS A RESULT OF ITS REGISTRATION AS AN INVESTMENT ADVISER WITH THE COMMISSION.
