That guidance essentially permits a GP entity to a private fund to rely on the Form ADV of the fund's investment adviser. In addition, as an ERA, the Registrant is not subject to Rule 205-3 under the Advisers Act, and it is not currently subject to a state law equivalent, which would require fund investors to be qualified clients. As a result, Registrant has marked "no" in response to question 15(b) of Schedule D, Section 7.B.(1). Regarding Schedule D, Section 7.B. (1), Questions 23(a)-(h), the Registrant notes that it is not subject to the Rule 206(4)-2 under the Advisers Act (the custody rule) or a state law equivalent. That said, it intends to have the financial statements of its private fund client audited and distributed to investors on an annual basis once its first fiscal year is completed. Finally, regarding Schedule D, Section 7.B.(1) for each of its private fund clients, Question 25(a), the Registrant notes that its private fund clients maintain their cash reserves with Citizens Bank.
