Ms. Bachelder typically contributes her own capital to these investments, but also receives all or a portion of the net profit after sale, following a return of investor capital, plus an agreed upon return on such investor capital. Ms. Bachelder’s receipt of net profit distributions creates a conflict of interest with respect to participating FWA clients. To address this conflict of interest, Ms. Bachelder, in the exercise of her fiduciary duty, (i) only offers the opportunity to participate in such investments to qualified FWA clients (relying on the criteria set forth above as well as additional information elicited by Ms. Bachelder during such client’s advisory relationship with FWA), (ii) provides full and complete disclosure with respect to both the risks of the opportunity and Ms. Bachelder’s financial interest in the project, and (iii) Ms. Bachelder does not accept fees to serve as the manager of any real estate investment entity, nor does FWA charge participating clients AUM or other fees on assets invested in any such entity. Ms. Bachelder may elect to serve as the manager for other real estate investment entities in the future, provided that is able to continue to allocate her time and resources between such projects and serving FWA’s clients in an appropriate manner and consistent with her fiduciary responsibilities.
