THESE COMMUNICATIONS WERE DISSEMINATED IN SEMINARS, IN RADIO AND TELEVISION ADVERTISEMENTS, IN PRINT ADVERTISEMENTS, THROUGH ELECTRONIC COMMUNICATIONS, AND ON THE FIRM'S WEBSITE.
