While all performance presented is based on current data for actual investments as of the date of the presentation, we provide target returns for unrealized investments based on estimated cash flows for the project through the anticipated exit date, which we consider "hypothetical". We have responded "yes" to Item 5.L.(4) regarding predecessor performance to reflect the fact that the firm reports a track record that includes prior firms that were renamed and consolidated into the current adviser. A Form D was not filed as this transaction did include the offering or sale of securities since each member of that venture has control, and it was a negotiated JV agreement between three represented parties. Given the relative ownership percentages and corresponding management rights, a Form D was not necessary.
