Strenta Investment Management Services, LLC ("SIMS" or the "Registrant") provides the following clarifying comments to further enhance disclosures in Items 7.A. and 7.B, as well as Section 7 of Schedule D, of this Form ADV: In 2025, SIMS' sole client The Century Partnership, Ltd, (f/k/a/ "Strenta Fund I, Ltd") (the "Fund") underwent a restructuring which resulted in the dissolution of two entities from the Fund's old structure who were previously disclosed in SIMS' Form ADV: (1) the limited partnership who was the Fund's sole investor prior to the restructuring; and (2) the feeder fund entity. Consequently, the Fund is no longer structured as a master-feeder arrangement. Moreover, Oak Services Limited ("Oak"), which was the Registrant's "Relying Adviser" since SIMS' initial registration with the Commission, is no longer acting as the general partner of the above referenced limited partnership or performing any functions for the Fund. As of the date of this filing, Oak is in the process of being dissolved and, consequently, has been removed as a "Relying Adviser" of SIMS. Strenta Fund Control Services, LLC ("SFCS"), a Delaware, U.S. limited liability company and an affiliate of the Registrant, is the Controlling Member of the Fund (holds management shares of the Fund and oversees the Fund's general administration). SFCS does not perform investment advisory functions but is listed for transparency in Item 7.A.(16) of this Form ADV.
