UNDER THE CONTRACTUAL TWO YEAR BUY-SELL AGREEMENT, THE RETIRING ADVISOR WAS TO AID IN THE TRANSITION BY ACTING SOLELY IN A SERVICING CAPACITY AND NOT ENGAGE IN ADVICE OR SOLICITATION. THE ADVISOR NO LONGER HAD ACCESS TO HIS FORMER CLIENTS' ACCOUNTS, NOR COULD HE AFFECT TRADES OR DO ANY SERVICING HIMSELF. AT FIRST, THIS BOUNDARY WAS MAINTAINED. TO THE FIRM'S KNOWLEDGE THE ADVISOR WAS BARELY DOING ANYTHING WITH RESPECT TO HIS FORMER CLIENTS - ALL SERVICING ISSUES WERE PASSED ALONG TO THE FIRM.
