OF 1940. AS IT BECAME APPARENT THAT ROCKHOUSE HAD A VIABLE BUSINESS MODEL THAT WOULD SERVICE MORE THAN 15 CLIENTS, INCLUDING HIGH NET WORTH INDIVIDUALS, BUT WOULD NOT SOON REACH \$25 MILLION IN ASSETS UNDER MANAGEMENT, IT COMMENCED THE PROCESS TO REGISTER IN CONNECTICUT. DURING THE PROCESS OF REGISTRATION, THE STATE OF CONNECTICUT INFORMED ROCKHOUSE WE COULD NOT RELY ON THAT EXEMPTION.
