SCHEDULE D 1.F. Records are no longer kept at 999 Vanderbilt Beach Blvd, Suite 200 Naples, FL 34108. All company records are now kept at the private residence of the qualifying representative. No clients are seen at this location. This location is used for record keeping, administration, and virtual or telephone interactions with clients and vendors. Regarding insurance agent activities - the firm's qualifying advisor is a licensed insurance agent as disclosed in form ADV2. The insurance business is as a sole proprietor, and also uses the brand name "RealRetirementIncome.com. No insurance products are sold that are investment related. The address for insurance activities is the qualifying representatives private residence. The qualifying representative spends approximately 1 - 3 hours per month on this activity, primarily outside trading hours. Regarding Custody: The Advisers Act imposes certain duties on registered Advisors that have custody or possession of Client funds or securities. State Administrators, which, in addition to the SEC have regulatory jurisdiction over ACI, have different interpretations of the relevant statute regarding custody. Texas and Florida State Administrators are in agreement that if an RIA does not have the ability to directly access client funds for any reason, they are deemed not to have custody. This is in line with the SEC which generally takes the view that an Advisor has custody if it directly or indirectly holds Client assets, has any authority to obtain possession of them or has the ability to appropriate them. ACI does not hold client assets, has no ability to obtain possession of client assets and no ability to appropriate them. Although ACI will never take physical custody of Client funds or securities, the State of CA interprets the relevant code (Rule 206(4)-2 differently than the State Administrators of Texas, Florida and the SEC and have argued that ACI has custody of client assets because a client is able to authorize the 3rd party custodian to pay fees to ACI as the Advisor on their account, with such fees deducted from their account by the 3rd party custodian and then paid by the 3rd party custodian to ACI. This is notice that the State of CA may regard ACI to have custody of client assets, even though the State of Texas, State of Florida, the SEC, Interactive Brokers, LLC (the 3rd party custodian) and ACI all agree that ACI does not have custody of client assets under the Rule. As such, at the behest of the State of California, ACI must comply with Rule 206(4)-2, the custody rule under the Advisers Act by giving notice that the State of California may consider ACI to have custody of client assets.
