A DIVERSIFIED PORTFOLIO OF STOCKS, BONDS AND CASH INSTRUMENTS WAS RECOMMENDED. HE REJECTED ADVISER RECOMMENDED PORTFOLIO IN LIEU OF AN AGGRESSIVE GROWTH PORTFOLIO OF ALL STOCKS WHICH WAS BEGUN IN MARCH OF 2000 WITHIN DAYS OF THE ALL TIME NASDAQ HIGH. THE MONEY WAS SPLIT AMONG MONEY MANAGERS IN A WRAP FEE PROGRAM.
