The GP Entity is not filing its own Form ADV but is instead relying on the interpretive guidance outlined in the “Frequently Asked Questions on Form ADV and IARD” on the SEC’s website under the heading “Reporting to the SEC as an Exempt Reporting Adviser.” That guidance essentially permits a GP entity to a private fund to rely on the Form ADV of the fund’s investment adviser. In addition, as an ERA, the Registrant is not subject to Rule 206(4)-2 under the Advisers Act (the custody rule) or a state law equivalent.
