Charles Schwab requested a "yes" notation because the firm has standing letters of authorization to transfer money from its clients' accounts to their bank accounts. In several cases the the bank accounts are not titled exactly as the clients' advisory account. In those cases, Charles Schwab considers this custody. But, please note, the firm cannot wire transfer any client assets to any third party accounts.
