We have existing clients with PCS Retirement as a 401(k) provider and recordkeeper; they use different custodians; our total client assets with them total less than one million. We recommend the services of 401GO, a 401(k) platform provider; 401GO uses Matrix Trust Company as custodian; our total clients assets with them total \$386,950. Item 9.A. Thompson Financial LLC is deemed to have custody solely because we have signed letters of authorization (SLOAs) from clients allowing us to move money from the client's account to a designated third party without obtaining a signed authorization each time; 100% of the numbers provided in Item 9 are related to this custody for SLOAs. We are in compliance with each of the requirements and conditions enumerated in Washington State's Securities Act Policy Statement 23, either through our own internal processes or confirming those controls are in place through our qualified custodian.
