Sand Spring Fund LP was previously a legacy 3(c)1 exempt fund of funds not accepting new investors, involving only the Principal of Sand Spring Advisors LLC and his IRA account as ultimate beneficial owners, and was awaiting the run-off of previous side-pocketed investments for a number of years. The Partnership had de Minimis ending assets of approximately \$17,000 for most of 2019 and was closed as a Partnership with the State of Delaware on December 23, 2019. Sand Spring Advisors LLC has not had direct discretionary authority over any portfolio since that time.
