Such withdrawal shall only be accomplished through the engagement of a qualified unaffiliated intermediary (e.g., custodian of record) where client accounts are separately held in that client's name, and pursuant to a prior written agreement with the client, and following Adviser's periodic fee notice. The Adviser has established a reasonable basis for believing that the qualified custodian sends an account statement at least quarterly to each client that it maintains funds or securities, identifying the amount of funds and each security in the client account at the end of the period, and setting forth all transactions in the account during that period.
