Commissions are fully disclosed and paid directly to the advisor by the underlying insurance carriers from the carriers' internal revenue, without reducing the client's principal, growth, or guaranteed income. The non-annuity portions of these retirement income portfolios typically utilize securities for the long-term growth and preservation segments of the overall plan, guided by a time-segmented, passively-managed (strategic), risk-adjusted allocation strategy using low-cost ETF blends. All securities accounts are held at Schwab under the advisor's hierarchy and are actively assisted with recommended allocation models and ongoing monitoring. However, the advisor does not charge advisory (AUM) fees or receive compensation for ongoing asset management for any clients who have placed annuity business (of any amount) with the advisor. Because the advisor is compensated through fixed annuity commissions, and in an effort to minimize client fees/costs in alignment with a fiduciary standard, no additional advisory fees are billed for ongoing portfolio guidance. Investment advice and ongoing monitoring are provided as part of the planning engagement, not through a fee-based discretionary (AUM) management relationship.
