IN ADDITION, THE REIT RESULTED IN REALIZED PROFITS FOR ALL CLIENTS. THE COLE PROSPECTUS DESCRIBED TWO OFFERRING OPTIONS. ONE FOR BD'S AND ANOTHER FOR RIA'S BD SALES HAD AN OFFERRING PRICE OF \$10 PER SHARE WITH A 7% COMMISSION BEING PAID BY THE ISSUER TO THE BD. IN OTHER WORDS, IF THE CLIENT PURCHASED \$25,000 OF SHARES AT \$10 PER SHARE, THAT ENTIRE PRINCIPAL AMOUNT WAS APPLIED TO THE SHARE PURCHASE.
