Charles Schwab is the custodian of the securities and they will normally issue a statement each month, or at least quarterly, and mail it directly to the client showing positions and account activity. We also mail a statement each month along with a newsletter and a quarterly invoice for management fees based upon contract provisions.We encourage clients to compare our statement and invoice with the one from their custodian.Our statement differs from the Schwab statement in that we are showing balances and total market value of the accounts without showing the daily activity detail shown in the Schwab statement.
