Effective May 15, 2026, Daniel J. Matheson's registration as an Investment Adviser Representative of the firm terminated. Mr. Matheson, individually, owns K2 Business Group, LLC and K2 Tax Group, LLC, separate legal entities that provide insurance and tax services. These entities are no longer related persons of the firm, and the firm has no common ownership, common supervised persons, or common management with them. The firm's prior referral and revenue-sharing arrangements with K2 Business Group, LLC and K2 Tax Group, LLC have been terminated and are no longer in effect. The firm receives no

compensation, in any form, in connection with referrals to these entities. Clients are under no obligation to use these entities for any service. The Adviser has custody of client funds and securities solely as a result of Standing Letters of Authorization (SLOAs). The Adviser is complying with each of the seven requirements and conditions enumerated in the February 2017 SEC No-Action Letter to the Investment Adviser Association. As of this filing, 15 clients with a total of \$1,626,109 are included in the Item 9 custody figures solely because of these SLOAs. Two Tree Financial, LLC dba K2 Wealth Management previously participated in a wrap fee program but no longer offers one as of May 2025.
