Schwab is custodian and sends monthly statements to Elena and her CPA who is also the trust CPA showing all transactions and check disbursements. In addition, I keep a running tally of every check ever written and send everyone listed above a year-end accounting statement. The other Trust, was established in 1978 among my five siblings relating to a property in Inverness, Florida that has been in my family for over 140 years. I have been managing the property for over 43 years and paying the bills. I am paid a monthly property management fee. When I sold enough land to "fund" the trust by investments 15 years ago, I purchased some high dividend and interest paying securities in a newly opened Schwab account and there has been limited investment activity since we use the income to defray our costs. I am not paid an additional fee for money management though I am authorized to pay myself my monthly property management fee. The dividends from the Schwab account are sent to the Bank of Inverness from which all bills, including my monthly check, are paid. In addition, I keep a full accounting of every expense, including me, and submit a yearly accounting to my siblings. Further, our family CPA gets the annual statement for Schwab and prepares our individual 1099s.
