AMG Wealth also serves as administrator of the AMG BBH Asset-Backed Credit Fund (the "AMG BBH Fund" and, collectively with the Mutual Funds and AMG Pantheon Funds, the "Funds"). Each of the Mutual Funds, AMG Pantheon Fund, LLC, AMG Pantheon Master Fund, LLC, AMG Pantheon Credit Solutions Fund, AMG Pantheon Infrastructure Fund, and AMG BBH Asset-Backed Credit Fund is a registered investment company under the Investment Company Act of 1940. AMG Wealth acts as the investment manager of each Mutual Fund pursuant to the terms of an investment advisory agreement. For the AMG Pantheon Fund, LLC, AMG Pantheon Master Fund, LLC, AMG Pantheon Subsidiary Fund, LLC, AMG Pantheon Lead Fund, LLC, AMG Pantheon Credit Solutions Fund, AMG Pantheon Credit Solutions Subsidiary Fund, LLC, and AMG Pantheon Credit Solutions Lead Fund, LLC, Pantheon Ventures (US) LP, an AMG Affiliate, serves as the investment adviser. For the AMG Pantheon Infrastructure Fund, LLC, AMG Pantheon Infrastructure Subsidiary Fund, LLC and AMG Pantheon Infrastructure Lead Fund, LLC, Pantheon Infra Advisors, LLC, an AMG Affiliate, serves as the investment adviser. For the AMG BBH Fund, Brown Brothers Harriman Credit Partners, LLC, an AMG affiliate, serves as the investment adviser. The Firm

receives advisory and/or administration fees from the Funds. AMG Wealth does not charge fees based on performance or the net profits of the assets being managed, other than a “fulcrum” fee which is charged to shareholders of one Mutual Fund. Such fulcrum fee, which is considered a performance-based fee, causes the Mutual Fund’s fee to increase or decrease on the terms and parameters as described in the Mutual Fund’s prospectus. For the Mutual Funds, the Firm has entered into subadvisory agreements with AMG Affiliates (each, a “Subadviser”) under which the Firm pays each Subadviser a fee. The Firm also has agreements with certain AMG Affiliates under which the Firm provides non-discretionary services such as marketing and client services, and certain limited administrative services, to support their provision of advisory services through sponsored programs, including wrap programs. The Firm has also entered into agreements with certain AMG Affiliates under which the Firm provides consulting and marketing services related to the marketing of the AMG Affiliates’ advisory services to sponsors of subadvised funds, institutional clients or other platforms. The Firm receives a fee from the AMG Affiliate for these services which may depend on whether the AMG Affiliate is engaged by the fund sponsor, institutional client or other platform. For this line of business, the Firm may do business as “AMG Distributors.” AMG Wealth may also compensate certain AMG Affiliates that serve as Subadvisers to the Mutual Funds, from its assets, for portfolio marketing support, client and intermediary relationship support and other services as agreed upon from time to time. The Firm also has agreements with certain firms, under which AMG Wealth provides nondiscretionary services such as back office support, administrative assistance, and marketing services, to support the AMG Affiliates’ provision of advisory services through third-party sponsored programs, including wrap programs. AMG Wealth is paid a fee by the AMG Affiliates for these servicing arrangements. In addition, certain of these firms may compensate AMG Wealth in connection with client solicitation and related services. AMG Wealth is the sole shareholder in AMG Distributors, Inc. (“AMGDI”), a broker-dealer that serves as the distributor of the Funds, the distributor of certain mutual funds sponsored by AMG Affiliates, and the placement agent for certain private funds sponsored by AMG Affiliates. As part of these arrangements, AMG Wealth and AMGDI provide administrative, marketing and distribution support service to the AMG Affiliates for the servicing or distribution of their funds through various distribution platforms, with AMG Wealth and/or AMGDI being compensated by these AMG Affiliates for these services. In addition, certain employees of AMG Wealth and of other AMG Affiliates that serve as Subadvisers to the Funds or advisers to the other funds described above are registered representatives of AMGDI. Certain AMG Affiliates may use the Funds for their clients, which would result in the Firm and/or an AMG Affiliate earning advisory, distribution and/or other fees in addition to fees otherwise payable to the Firm and/or the AMG Affiliate.
