Upon identifying the issue, the Firm conducted a review of its Form ADV filing obligations and promptly completed corrective actions. These actions included: (i) review and update of Form ADV Part 1 and Part 2B brochure supplements, (ii) assessment of whether any brochure/supplement delivery obligations were triggered and completion of any required delivery, and (iii) implementation of enhanced compliance controls to prevent recurrence. The Firm has documented the circumstances, remediation steps, and preventive measures in its books and records. The Firm submits that its reliance on the third party service provider was reasonable and respectfully requests that it is taken into account.
