THE FIRM ALSO FAILED TO DETERMINE WHETHER THE REPRESENTATIVE UNDERSTOOD THE UNIQUE FEATURES AND SPECIFIC RISKS ASSOCIATED WITH NT-ETPS AND THEREFORE COULD NOT DETERMINE WHETHER THE REPRESENTATIVE LACKED A REASONABLE BASIS FOR MAKING THE RECOMMENDATIONS. THE FINDINGS ALSO STATED THAT THE FIRM FAILED TO REASONABLY SUPERVISE THE REGISTERED REPRESENTATIVE'S RECOMMENDATIONS OF COMPLEX OPTIONS TRADING. THE FIRM WAS AWARE OF RED FLAGS IN THE RISKY OPTIONS TRADING BUT FAILED TO REASONABLY INVESTIGATE WHETHER THE TRADING WAS SUITABLE FOR THE CUSTOMERS. THE REPRESENTATIVE RECOMMENDED VARIOUS FORMS OF OPTIONS SPREAD STRATEGIES TO MULTIPLE CUSTOMERS THAT INVOLVED PURCHASING NUMEROUS OPTIONS CONTRACTS AT DIFFERENT STRIKE PRICES AND THE SAME EXPIRATION DATES. THE COMMON GOAL WAS TO LIMIT RISK WITH A KNOWN MAXIMUM LOSS AS WELL AS A MAXIMUM PROFIT. HOWEVER, SOME OF THE TRADES PRESENTED AN UNREASONABLE RISK SINCE THE POTENTIAL MAXIMUM LOSS WAS AS MUCH AS NINE TIMES GREATER THAN THE MAXIMUM PROFIT. IN SOME CASES, THE OVERALL POSITIONS GUARANTEED A LOSS. THE FIRM'S WSPS REQUIRED THE FIRM TO REVIEW EACH OPTIONS TRANSACTION TO DETERMINE SUITABILITY. HOWEVER, THE FIRM FAILED TO REASONABLY SUPERVISE THE REPRESENTATIVE'S ACTIVITIES AND CUSTOMER ACCOUNTS TO TIMELY DETECT WHETHER THESE COMPLEX OPTIONS TRANSACTIONS WERE COMPATIBLE WITH THE INVESTMENT OBJECTIVES OF EACH CUSTOMER.
