("WEBCO") AND DELPHAX TECHNOLOGIES INC. ("DELPHAX"), THINLY-TRADED SECURITIES THAT CURRENTLY TRADE IN THE OVER-THE-COUNTER MARKET. GIVEN HIS SINCERE BELIEF IN THE POTENTIAL VALUE OF THESE STOCKS, JAMES W. NICHOLS PURCHASED THESE STOCKS FOR BOTH HIS CLIENTS AND FOR HIS OWN PERSONAL ACCOUNT AND THE ACCOUNTS OF HIS FAMILY MEMBERS. IN ORDER TO DISCLOSE THIS PRACTICE, JAMES W. NICHOLS CHECKED THE APPROPRIATE BOX ON FORM ADV INDICATING THAT HE BUYS AND SELLS FOR HIS PERSONAL ACCOUNT SECURITIES THAT HE ALSO RECOMMENDS TO CLIENTS. NICHOLS DID NOT MAINTAIN ADEQUATE WRITTEN SUITABILITY INFORMATION FOR EACH CLIENT IN HIS CLIENT FILES AND DID NOT CONDUCT A COMPLETE SUITABILITY ANALYSIS FOR EACH CLIENT IN ORDER TO DETERMINE WHETHER IT WAS SUITABLE FOR EACH CLIENT TO INVEST IN SMALL CAP STOCKS AND THINLY-TRADED SECURITIES.
