The termination was entirely voluntary and administrative, not disciplinary. There were no client complaints, regulatory inquiries, or enforcement actions during this time. The firm now intends to recommence registration under the same name, J. Oliver Maxwell, LLC, with CRD No. 338783, maintaining its principal office and business model. Corrective measures undertaken include: Revising and reformatting Form ADV Parts 1, 2A, and 2B for clarity and compliance.
