WaterEquity conducts its business through virtual meetings and on-site due diligence at the locations of private fund investors and investees. Employees may occasionally meet in person in Kansas City or at temporary co-working spaces to facilitate internal collaboration. WaterEquity does not list individual home offices in response to Section 1.F. of Schedule D for two reasons. (1) doing so could mislead private fund investors into believing WaterEquity maintains numerous offices; and (2) because home office addresses are redacted on public filings, including them would diminish rather than enhance the utility of the Form ADV. No other business activities are conducted at any individual home office, including activities as a: (1) broker-dealer (registered or unregistered), (2) bank (including a separately identifiable department or division of a bank), (3) insurance broker or agent, (4) commodity pool operator or commodity trading advisor (whether registered or exempt from registration), (5) registered municipal advisor, (6) accountant or accounting firm, or (7) lawyer or law firm.No other investment-related business activities are conducted from any individual home office other than the investment-related business activities disclosed in Form ADV and in private fund offering documents. All employees, regardless of geographic location, are subject to the same WaterEquity policies and procedures. No individual home office is exempt. WaterEquity oversees compliance through its annual compliance review process and annual compliance training. A complete list of the city, state, and country of each individual home office will be

provided to investors and regulators promptly upon request. Regarding Item 3.B. WaterEquity reported in response to Item 3.B. that its fiscal year ends on December 31 each year. Following its consolidation with Water.org effective October 1, 2025, WaterEquity changed its fiscal year end to September 30 to align with that of its new sole member. The private fund and RAUM information presented in this filing is as of December 31, 2025. WaterEquity will file its next annual updating amendment to Form ADV in Q4 2026, within 90 days of its new September 30 fiscal year end.
