Crestwood provides operational and other support to Crestwood Capital International, Ltd. and Crestwood Capital Partners, L.P. (collectively the "Feeder Funds"), but does not exercise discretion over the management of the

assets of the Feeder Funds, each of which invest all of their investable assets in the Master Fund. From time to time, the Feeder Funds do maintain relatively small asset balances, for example to fund certain expenses and redemptions. To avoid counting assets twice due to the master feeder structure and the fact that Crestwood does not have discretion over assets held in the Feeder Funds, the discretionary RAUM (Item 5 F (2) (a)) includes the assets invested by the Feeder Funds into the Master Fund, and the non-discretionary RAUM (Item 5 F (2) (b)) includes the Feeder Fund assets that have not been invested in the Master Fund, and over which Crestwood does not exercise discretion. The total RAUM (Item 5 F (2) (c)) reflects the total RAUM managed by Crestwood.
