Inverlochy Capital Group Ltd. owns and controls 100% of Inverlochy Capital Ltd. Inverlochy Capital Ltd. is the Canadian operating company of the group. 3. Inverlochy Capital

Ltd. owns and controls 100% of Inverlochy Capital, Inc. the SEC registrant. Therefore, the change of formation and corporate reorganization did not result in a practical change in control or management. W. Glen Morrison still ultimately owns and controls 100% of the SEC registrant.
