This note explains why Item 4a regarding Successions is answered "No," and is being supplied as recommended in Staff Guidance Concerning Investment Adviser Reliance on Predecessor Registrations, IM Guidance Update No. 2016-05 (2016), at page 4. Whether a conversion from a corporation to an LLC raises succession concerns "depends on the particular facts and whether a new entity has been created." IM 2016-05, p. 1. Under Georgia law, a conversion from a corporation to an LLC does not result in a dissolution of the corporation and creation of a new entity. O.C.G.A 14-11-212(d) ("A limited liability company formed by an election pursuant to this Code section shall for all purposes be deemed to be the same entity as the entity making such election."). Because the change of organization does not result in the creation of a new entity, the registrant continues to exist and may operate under its effective registration. See, e.g., Registration of Successors to Broker Dealers and Investment Advisers, Release No.34-30661 (1992) at text accompanying note 21 (describing the basis for succession when there is a "formal change in the structure or legal status of the broker-dealer or the adviser: i.e., successions that involve the creation of a new legal entity . . ."); IM 2016-05 (2016) at text accompanying note 11 ("The premise behind the ability of an adviser to file as a successor by amending its Form ADV is that a change of . . . the form of a business . . . results in the dissolution of the previous organization and the de facto creation of a new legal entity that has taken over the business of the previous organization."). There is no other ostensible need for a succession filing other than the change of organization issue. No new unregistered entity will be performing advisory services, and the change of control that occurred has been addressed in the standard way by amending Schedules A and B to Form ADV Part 1. See 2016-05 at note 18. Annual Updating Amendment was incorrectly filed on March 27, 2026 as an 'Other-Than-Annual Amendment' in error by COMPLY.
