In order to be consistent with Form PF, for Schedule D Section 7B(1) Questions 14-16, with the exception of DFW Capital Partners VIII, L.P., DFW has reported the percentages of beneficial ownership of related persons, funds of funds, and non-US persons based on the percentage of partner equity (as opposed to percentage of regulatory assets under management). As DFW Capital Partners VIII, L.P. has not commenced investment activity, DFW has reported the percentages of beneficial ownership of related persons, funds of funds, and non-US persons based on regulatory assets under management (which equaled unfunded commitments as of December 31, 2025). DFW Capital Partners VIII, L.P. answered "no" to Schedule D Section 7B(1) Question 23(g) as it has not yet commenced operations and therefore does not have audited financial statements for 2025. DFW expects the fund to commence operations some time in 2026. While DFW Capital Partners VIII, L.P. has not yet signed an engagement letter, it intends to engage Grant Thornton LLP (the auditor for the other DFW funds) as its auditor, and has therefore listed Grant Thornton LLP in its response to Schedule D Section 7B(1) Question 23(b). DFW creates SPVs to act as general partner or managing member for DFW's private funds. The SPVs rely upon DFW's registration with the Commission and are not separately registered. DFW has omitted Schedule Rs in reliance on the FAQ posted June 12, 2017 discussing the staff's position that Schedule R filing would not be required for an SPV that meets the conditions described in the 2005 Staff Letter. DFW has reported under Item 5(L) that it includes in advertisements specific investment advice. The response for Item 5.L.1(b) is “yes” but does so in compliance with the requirements of the Marketing Rule,

meaning that it is fair and balanced. The specific investment advice and hypothetical performance typically pertains to deal level performance (IRR) or projected deal performance shown on a net basis. Testimonials shown are case studies by portfolio companies demonstrating operational (not financial) performance. Endorsements relate to placement agent arrangements whereby DFW pays compensation for the solicitation of fund investors. Each Custodian of the Private Funds reported in Schedule D, Item 7.B.1.25(a) may hold the assets of the Private Fund at different locations and/or branches within such Custodian.
