FROM 2012-2016, ATLAS RECEIVED NUMEROUS CLIENT REFERRALS FROM AN UNAFFILIATED FIRM. THE UNAFFILIATED FIRM WOULD TYPICALLY RECOMMEND AND OPEN SERVICE CLASS CUSTODIAL ACCOUNTS FOR CLIENTS, WHICH ACCOUNTS COULD ONLY ACCEPT SERVICE CLASS MUTUAL FUND SHARE CLASSES THAT PAID 12B-1 COMPENSATION AND SHAREHOLDER SERVICE FEES TO THE REGISTERED REPRESENTATIVES OF THE UNAFFILIATED REFERRING FIRM. BECAUSE THE TYPE OF ACCOUNT OPENED WITH THE MUTUAL FUND DISTRIBUTOR DICTATED THE TYPE OF SHARE CLASS THAT COULD BE PURCHASED, THE SELECTION AND OPENING OF A PARTICULAR ACCOUNT TYPE BY THE REFERRING FIRM WAS TANTAMOUNT TO THE SELECTION OF A PARTICULAR SHARE CLASS.
