Steinberg (“Mr. Steinberg”), an advisory affiliate as well as the organization’s control person. While the response to each question in Item 11 is “No”, the following information provides additional context regarding past actions against Mr. Steinberg. Prior criminal action: On March 29,2013, the U.S. Attorney’s Office unsealed a superseding

indictment charging Mr. Steinberg with unlawfully trading securities of Dell Inc. and Nvidia Corporation based on material non-public information obtained from corporate insiders. On December 18, 2013, following trial, a jury found Mr. Steinberg guilty of all charges. The Honorable Richard J. Sullivan of the Southern District of New York sentenced Mr. Steinberg on May 16, 2014 and entered judgment three days later. On October 30, 2015, following a decision of the Second Circuit in the related case of United States v. Newman, 773 F.3d 438 (2d Cir. Dec. 10, 2014), Judge Sullivan signed a nolle prosequi, thereby vacating Mr. Steinberg’s conviction and dismissing the indictment against him. Prior regulatory action: On October 16, 2014, an administrative law judge at the U.S. Securities and Exchange Commission (the “SEC”) entered an initial decision barring Mr. Steinberg from association with an investment adviser, broker, dealer, municipal securities dealer, municipal advisor, transfer agent, or nationally recognized statistical rating organization. On November 4, 2014, Mr. Steinberg appealed such initial decision. The follow-on administrative proceeding was instituted against Mr. Steinberg under Section 203(f) of the Investment Advisers Act of 1940 based on his criminal conviction for insider trading. The SEC subsequently postponed briefing on Mr. Steinberg’s petition for review in light of developments in the related case of United States v. Newman. On October 30, 2015, a district judge in the United States District Court for the Southern District of New York vacated Mr. Steinberg’s conviction and dismissed the indictment against him. On November 24, 2015, the SEC entered an Order Dismissing Proceeding to dismiss the administrative proceeding against Mr. Steinberg.
