We are a wholly owned subsidiary of Focus Financial Partners, LLC ("Focus"), and Focus is a minority investor in UPTIQ, Inc. The range of services offered or expected to be offered by UPTIQ to our advisory clients includes, but is not limited to, omnibus cash management products, individual level deposits, non-purpose securities-backed lines of credit, commercial loans, aircraft and marine loans, non-securities-based/asset-secured loans, and residential mortgage loans.
