In the context of the question in Section 7.B. 1 regarding whether sales of interests in MGG's funds are limited to “qualified clients,” please note that MGG’s non-US domiciled funds are non-US residents and, therefore, pursuant to the exemption set forth in Section 205(b)(5) of Advisers Act, the performance fee prohibition of Section 205(a) of the Advisers Act does not apply to investment advisory contracts with MGG’s Cayman Islands-domiciled funds. MGG manages certain fund structures involving a feeder fund (e.g., MGG Structured Solutions Fund (Cayman) LP) that invests into two master funds (e.g., MGG Structured Solutions Master Fund (Cayman) LP and MGG Structured Solutions Master Fund LP). Due to the inability to determine how to allocate the uncalled commitments of such feeder fund to the two related master funds in connection with calculating such master funds’ respective gross asset values, in Section 7B1 of Schedule D, MGG is allocating the entire gross asset value of this master feeder structure to one of the two master funds (e.g., MGG Structured Solutions Master Fund (Cayman) LP in the above example). As such, the Section 7B1 private fund reporting schedule for the other master fund (e.g., MGG Structured Solutions Master Fund LP in the above example) reports zero gross asset value for this master fund. MGG has responded “Yes” to Item 5L 1(d) herein as MGG utilizes one or more placement agents to solicit investors on behalf of certain Funds and Investment Advisers Act Rule 206(4)-1’s definition of an “endorsement” includes placement agent activity. However, MGG does not include any positive statements (or other types of endorsing statements) from any placement agent in its marketing materials. MGG has responded “Yes” to Item 8.B.2 herein as MGG recommends to advisory clients loans or other investments for which MGG may serve as administrative agent. However, MGG passes the financial benefits from this administrative agent role onto its advisory clients that participate in the relevant loan or other investment.
