Tuttle: BSC Tuttle, a Series of Belvedere Strategic Capital SPV Master LLC and Belvedere Strategic Capital, LP. Tuttle Capital Management (TCM) maintains an advisory affiliate, Tuttle Wealth Partners LLC (TWP), that has an insurance agency under common control with TWP and is used to conduct insurance-related business exclusively under TWP. Whereas TCM and TWP share certain supervised persons, none of the shared supervised persons are performing insurance business. Tuttle Capital Management previously filed a Form ADV Annual Amendment that included a succession in Item # 4 and subsequently filed an ADV Other-Than-Annual Amendment that removed the succession in Item # 4 but retained the Corporation status in Item #2. Each of these amendments were made in error. Tuttle Capital Management did not undergo a succession and has since its inception been organized as an LLC. Tuttle Capital Management converted from an LLC that elected to be treated as a S Corporation status to currently an LLC which elected C Corporation status tax treatment as of October 1, 2024. Tuttle Capital Management has not changed its organization structures and the aforementioned modification in tax status resulted in no other changes to the registrant including with respect to ownership, control, or business operations. This Other-Than-Annual Amendment is made to correct the errors noted in the previously filed amendment filings.
